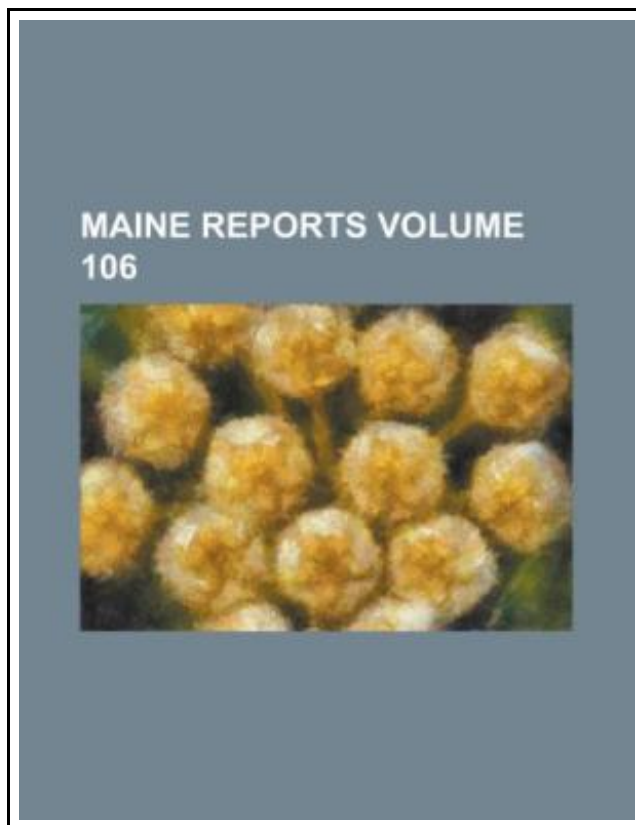

It is argued that the practical effect of such a construction of the statute would. be to make the company guarantee that the persons named by it for referees should not only be willing to serve when named, but that they shall remain alive and able and willing to serve during the entire limit of two years within which the action may be commenced. Several cases are also cited which are claimed to be in some respects analogous to that at bar and to lend some support to the defendants contention. In *Fisher v. Insurance Co.* , 95 Maine, 486, the referees were duly selected and made their award, but the plaintiff claimed that the award was invalid by reason of misconduct on the part of the referees, and sought to recover his damages in an action on the policy, irrespective of the amount awarded by the referees. There was neither allegation nor proof, however, that such misconduct was caused or participated in by the defendant, and it was accordingly held that if the award was invalid without fault of the defendant it was the duty of the defendant to seek a new determination in the manner provided by the contract. It will be seen that the question here decided was wholly different from that...
